We hereby confirm the following:

**Registration:**

The above mentioned products are considered to be 'articles' as defined in REACH Art.3.3. This finding is based upon official text of the regulation and the 'Guidance on requirements for substances in articles', (chapter 2.3: 'Deciding whether an object is an article or not') (v4 ECHA June 2017). Because these products are 'articles' and because there is no 'intended release', the substances from which they are produced are not subject to any registration requirements in accordance to REACH Art.6.

**Substances occurring on the Candidate List:**

Based on the information provided by the suppliers, the products mentioned above do not contain Substances of Very High Concern (SVHC) as listed on the Candidate List for Authorisation in a concentration exceeding 0.1% by weight.

All Twitchell products have been allocated Item Numbers. Using these numbers, customers may also check on the Twitchell website whether any SVHC is included into a specific Twitchell product. In accordance with REACH Art.33, customers can also check on the Twitchell website whether any instruction for safe use applies to a specific product and download the applicable information.

**Substances subject to Authorisation (Annex XIV REACH):**

In accordance with REACH Art.56(a), authorisation does not apply to a substance, which is incorporated into an article in the non-EEA (European Economic Area) countries. Please note that since Twitchell products are imported into the EEA as articles, authorisation is not applicable here. However, we can confirm that the products mentioned above do not contain substances subject to authorisation (Annex XIV REACH) in concentrations above 0.1% by weight.

**Restrictions on marketing and use (Annex XVII REACH):**

The products mentioned above were checked against the restriction list of Annex XVII. Either the substances listed in Annex XVII were not used or the uses of the substances in the products were not restricted.

All Twitchell products have been allocated Item Numbers. Using these numbers, customers may check on the Twitchell website whether any of these restrictions applies to a specific Twitchell product.

**Validity**

The findings as described in this certificate are based upon information provided to Knoell NL BV by Twitchell Technical Products, LLC and their suppliers. The findings are valid only for the products as produced in the Twitchell plant in Dothan, Alabama.

The following versions of the Candidate List (of January 19<sup>th</sup>, 2021) and the REACH Annexes XIV (December 18<sup>th</sup> 2020) and XVII (No 1907/2006 including amendments No 2021/57 of 25<sup>th</sup> January 2021) were used for the compilation of this certificate.
